



The 2buy2 energy basket combines the energy spend of multiple organisations into a single, larger volume of consumption. While many organisations understand the benefits of purchasing energy through wholesale markets, they often lack the annual kWh volume to access these opportunities directly.

By pooling like-minded customers into a single group, we create sufficient volume to trade on wholesale energy markets using a risk-managed approach, delivering better value for everyone involved.

Who Is It For?

Our flexible energy baskets are designed for both half-hourly and standard metered customers with no minimum annual consumption requirements.

These organisations can gain access to wholesale energy markets without needing a bespoke flexible energy contract.



Why don't I know my pricing before signing up?

By joining the basket now, you won't know the final price until September. While this requires a level of trust, thousands of customers have benefited from long-term price stability, and our past basket had a 98% retention rate over 10 years!

The 2buy2 Energy Basket operates as a flexible procurement model, allowing us to secure the best possible prices based on market conditions. Each year on 1st October, you'll receive your pricing for the next 12 months, providing predictability and stability. Future prices will be determined based on market-driven energy purchases, ensuring ongoing cost optimisation.

How long does the basket last?

The Energy Basket is a 5-year agreement, starting on 1st October 2025 with a carefully selected supplier, ensuring long-term price security and expert contract management. You can join at any time, with the contract running until the end of the agreement - 30th September 2030.

Can I still use my preferred supplier?

The energy basket is awarded through a competitive tender process to ensure best value and service. While you may not be able to choose your exact supplier, the selected provider meets strict quality and compliance standards, giving you confidence in your energy contract.

What happens if I need to leave the basket early?

We understand that needs change. You can exit the basket early by giving notice before 1st April 2028. Your contract will then end on 30th September 2028. This provides flexibility while maintaining the benefits of a long-term strategy.

What if my current energy contract ends before October 2025?

No problem! We offer interim contracts to cover any gaps, ensuring you have a seamless transition into the energy basket without being tied to an expensive short-term deal.




How It Works
